This course provides the individual with an understanding of the Pharmacology of drugs, and the necessary helper/counselor skills needed to affect change in substance abusers.

### **Short Term Client Systems • 46 Hours** March 2-3, 2018 & April 6-7, 2018

This course provides participants with listening and responding skills in the areas of empathy, values, attitudes and problem solving and Ethics.

### **The Assessment Intake & Treatment Planning (AITP)/DSM 5, The PPC-3 • 40 Hours** May 4-5, 2018 & June 1-2, 2018

This block provides the participant with skills needed to assess, diagnosis, recommend levels of care for treating the substance-abusing individual.
